WITNESSETH, that said party of the first part, in consideration of the sum of (\$10.00) Ten and No. 100.00 Dollars, and other good and valuable considerations in hand paid, does hereby grant, sell and convey unto said party of the second part, the following described real estate situated in Cook County, Illinois, to-wit: Unit No. 306 in The Randolph Condominium in Forest Park as delineated on a survey of the following described real estate: Lot 5 in Block 14 in Railroad Addition to the Town of Harlan, a Subdivision by the Galena and Chicago Union Railroad Company of the South East Quarter of Section 12, Township 39 North, Range 12, East of the Third Principal Meridian, according to the Plat thereof recorded November 26, 1958, in Book 160 of Maps, Page 15 in Cook County, Illinois; which survey is attached as Exhibit "A" to the Declaration of Condominium Ownership recorded as Document No. 25064808 together with its undivided percentage interest in the common elements. PARTY OF THE FIRST PART ALSO HEREBY GRANTS to Parties of the Second Part, their successors and assigns, as rights and easements appurtenant to the above described real estate, the rights and easements for the benefit of said property set forth in the aforementioned Declaration, and Party of the First Part reserves to itself, its successors and assigns, the rights and easements set forth in said Declaration for the benefit of the remaining property described therein. THIS DEED IS SUBJECT TO all rights, easements, restrictions, conditions, covenants and reservations contained in said Declaration the same as though the provisions of said Declaration were recited and stipulated at length herein.

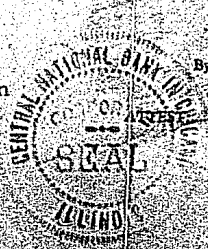

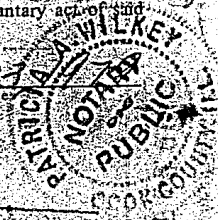
