13. Trustee shall release this trust deed and the lien thereof by prope instrument upon presentation of satisfactory evide or that all indebtedness secured by this trust deed has been fully paid; and Trustee may execute and deliver a release hereof to and at the cq test of any person who shall, either before or after maturity thereof, produce and exhibit to Trustee the note, representing that all indebt. ess hereby a prior trustee may accept as the genuine note herein described any note which bears an identification number purporting to be placed thereon by a prior trustee hereunder or which conforms in substance with the described herein described any note which may be presented and which purports to be executed by the persons herein designated as the makers thereof; and where the release is requested of the note and which purports to be executed by the persons

Trustee or successor shall be entitled to reasonable compensation for any other act or service performed under any provisions of this trust deed. The provisions of the "Trust And Trustees Act" of the State of Illinois shall be applicable to this trust deed.
