Parcel 1: Lots 1 and 2 (except the west 14 feet thereof) in Block 9 in Cochran's Second Addition to Edgewater in the East fractional 1/2 of Section 5, Township 40 North, Pange 14, East of the Third Principal Meridian, in Cook County, 11 nois.

Parcel 2: All the land lying Easterly of 1 to 1 and 2, Southerly of the North lot line of Lot 1 extended Easterly, Northerly of the South lot line of Lot 2 extended Easterly, and Vesterly of the boundary line established by decree of The Circuit Court of Cook County, Illinois in case number 67 CH 1768, and in Cook County, Illinois,
