17. Said parties of the first part further agree that upon default in the payment of any of the said instalments or of any of the obligations evidenced by the note secured by this Trust Deed, or of any of the covenants or agreements stipulated in this Trust Deed, they wall pay interest at the rate of -11.25- per cent per annum, or such statutory rate in effect at the time of execution, upon the total indebtedness so long as said default shall continue and further agree that upon such default the principal sum above mentioned, or such part thereof as may be unpaid, and any advances made by the Holders of the Note, together with interest as aforesaid. stall, at the option of the Holders of the Note, become immediately due and payable, without rotice, anything hereinbefore contained to the contrary notwithstanding.

18. Said parties of the first part further covenant and agree to deposit with the Trustee (r) he legal holder of the within mentioned note, on the 1st day of each and every month during the term of said loan, commencing on the 1st day of January , 1980 a sum equal to one-twelfth (1/12th) of the estimated general real estate taxes next accruing against said premises computed on the amount of last ascertainable Real Estate taxes and one-twelfth (1/12th) of the annual insurance premiums, such sums to be held in a non-interest bearing account by the Trustee or the Legal Holder of the note as and for a Sinking Fund to be used by the Trustee or the Legal Holder of the Note, to pay the general real estate taxes levied against said premises, and insurance premiums as and when the same become due and payable.

19. In the event of a Sale or Conveyance of the property described herein the entire balance remaining unpaid on this mortgage shall become due and payable immeditely at the option of the Holder of the Note.
