That part of the East one-half of the South East quarter of Section 22, Township 36 North, Range 13, East of the Third Principal Meridian, described as follows: Beginning at a point on the Westerly line of Crawford Avenue 200 feet North of the point of the intersection of the Northerly line of 167th Street and the Westerly line of Crawford Avenue (said Westerly line being 50 feet West of the East line of Section 22 aforesaid); thence North along the Westerly line of Crawford Avenue a distance of 250 feet; thence Westerly parallel with the North line of 167th Street a distance of 510 feet; thence Southerly parallel to the West line of Crawford Avenue a distance of 433 feet to the North line of 167th Street; thence Easterly along the North line of 167th Street, a distance of 310 feet; thence Northerly parallel to the West line of Crawford Avenue a distance of 183 feet; thence Easterly parallel to the North line of 167th Street a distance of 200 feet to the point of beginning, in Cook County, Illinois.
