Unit 1A , 705 Tipperary Court, Schaumburg, Illinois of Lakewood Condominium as delincated on plat of survey of a part of Lot 16131 in Section 2, What ersfield Unit 16, being a subdivision in the Northwest 1/4 of Sectior 2/, Township 41 North, Range 10 East of the Third Principal Merid an, in Cook County, Illinois; which plat of survey is attached as Exhibit "B" to Declaration of Condominium made by American National Bank and "rust Company of Chicago, a National Banking Association, as trustee under Trust Agreement dated May 30, 1979 and known as Trust No. 46656, recorded in the office of the Recorder of Deeds of Cook County, Illinois a Document No. 25252295; together with a percentage of the Common Flements appurtenant to said Unit as set forth in said Declaration, as amended from time to time, which percentage shall automatically change in accordance with Amended Declarations as same are filed of record pursuant to said Declaration, and together with additional Common Elements as such Amended Declarations are filed of record, in the percentages set forth in such Amended Declarations, which percentages shall automatically be deemed to be conveyed effective on the recording of each such Amended Declaration as though conveyed hereby.

Grantor also hereby grants to Grantee, his heirs, successors, and assigns, as rights and easements appurtenant to the above described real estate, the rights and easements for the benefit of the property set forth in the aforementioned Declaration, and Grantor reserves to itself, its successors, and assigns, the rights and easements set forth in sail Declaration for the benefit of the remaining property described herein.

This deed is subject to all rights, easements, restrictions, conditions, Covenants, and reservations contained in said Declaration as though the coprovisions of said Declaration were recited and stipulated at length herein; and all other covenants, conditions, restrictions, and easements of record.

The Tenant, if any, of this Unit has either waived or has failed to exercise his right of first refusal to purchase this Unit, or had no such right of first refusal, pursuant to the provisions of the Illinois Condominium Property Act.
