Witnesseth, That said party of the first part in consideration of the sum of Ten and 00/100 Dollars, and other good and valuable considerations in hand paid, does hereby grant, sell, convey and quit-claim unto said party of the second part, the following described real estate, situated in Cook County, Illinois, to-wit:

205, as delineated on a plat of survey of: A portion of the North $\frac{1}{2}$ of the North $\frac{1}{2}$ of Section 30, Township 41 North, Range 13 East of the Third Principal Meridian in the Village of Niles, Cook County, Illinois

which plat of survey is attached as Exhibit C to the Declaration of Condominium Ownership for Wood River Park Condominiums made by Grantor, recorded in Cook County, Illinois as Document No. 25031661 (the "Declaration"); together with the undivided percentage interest in the common elements appurtenant to said Unit as set forth in Exhibit D to the Declaration, as Exhibit D may be amended by an amendment to the Declaration ("Amendment") which may from time to time be recorded pursuant to the power reserved by Grantor in Article Eight of the Declaration, which undivided percentage interest shall automatically change as provided in an Amendment; and together with additional common elements as may be added or annexed by such Amendment, in the percentages set forth in such Amendment, which additional common element shall automatically be deemed to be conveyed effective upon the recording of such Amendment the same as though conveyed hereby.

Grantor also hereby grants to Grantees, their heirs, successors and assigns, as rights and easements appurtenant to the Unit, the rights and easements for the benefit of said property set forth in the Declaration. Grantor reserves to itself, its successors and assigns, the rights and easements set forth in the Declaration for the benefit of the remaining property described therein.

This deed is subject to all rights, easements, restrictions, conditions, covenants and reservations contained in the Declaration the same as though the provisions of the Declaration were recited and stipulated at length herein.

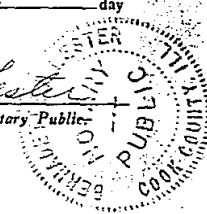
