WITNESSETH, that said party of the first part, in consideration of the sum of Ten and No/100 Dollars, (\$10.00*****) and other good and valuable

considerations in hand paid, does hereby grant, sell and convey unto said party of the second part, the following described real estate, situated in Cook County, Illinois, together with the tenements and appurtenances thereto belonging:

Unit No. 1230 3-S in Jarvis on The Lake Condominium as delineated on a survey of the following described real estate:

Lot 9 (except the west 25 feet thereof measured on the north and south lines thereof) and Lot 10 in Block 11 in the resubdivision of Blocks 1 and 12 in Birchwood Beach, a subdivision of part of Section 29, Township 41 North, Range 14 east of the Third Principal Meridian, in Cook County, Illinois.

which survey is attached as Exhibit A to the Declaration of Condominium recorded as document no. 25279270 together with its undivided percentage interest in the common elements.

Grantor also hereby grants to Grantee, its successors and assigns, all rights and easements appurtenant to the above described real estate, the rights and easements for the benefit of said property set forth in the aforementioned Declaration, and Grantor reserves to itself, its successors and assigns, the rights and easements set forth in said Declaration for the benefit of the remaining property described therein.

This Deed is subject to all rights, easements, restrictions, conditions, covenants and reservations contained in said Declaration the same as though the provisions of said Declaration were recited and stipulated at length herein.

Grantor herein states that either (i) Grantee was the tenant under a lease for the subject unit on the date, if any, on which a Notice of Intent to file a Condominium Declaration was given, or (ii) if Grantee was not a tenant as aforesaid, then such tenant either waived or failed to exercise the right of first refusal or had no right of first refusal with respect to the aforesaid unit.

TO HAVE AND TO HOLD the same unto said party of the second part as aforesaid and to the proper use, benefit and behoof of said party of the second part forever.

This Deed is executed pursuant to and in the exercise of the power and authority granted to and vested in said Trustee by the terms of said Deed or Deeds in Trust delivered to said Trustee in pursuance of the trust agreement above mentioned. This Deed is made subject to the lien of every Trust Deed (if any there be) of record in said county affecting the said real estate or any part thereof given to secure the payment of money and remaining unreleased at the date of the delivery hereof.
