between FIRST BANK OF OAK PARK, Oak Park, Illinois, an Illinois Corporation, under the laws of Illinois, as Trustee under the provisions of a deed or deeds in trust duly recorded and delivered to said First Bank of Oak Park in pursuance of a trust agreement dated the 15th day of April, 19 77 and known as Trust Number 10999 party of the first part, and ROBERT R. VON SCHWEDLER and MARY LOU VON SCHWEDLER, his wife, as joint tenants and not as tenants in common,

Witnesseth. That said party of the first part in consideration of the sum of TEN and NO/100ths Dollars, and other good and valuable considerations in hand paid, does hereby grant, sell, convey and quit-claim unto said party of the second part, the following real estate, situated in Cook County, Illinois, to-wit:

2. This Deed is subject to all rights, easements, restrictions, conditions, covenants and reservations contained in said Declaration the same as though the provisions of said Declaration were recited and stipulated at length herein.

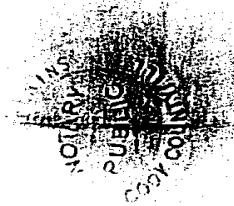
