This Indenture, Made this 22 day of November, 19 82,

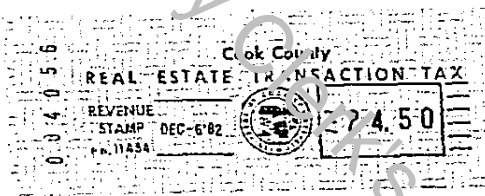
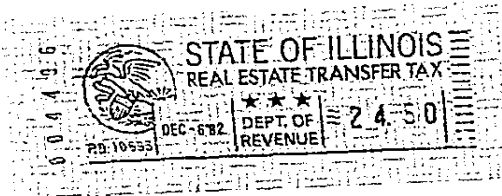
