WILLIAM DOCKS and WAYMAN DOCKS, parties of the second part.

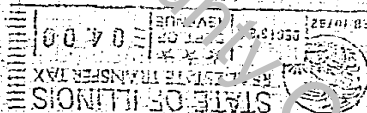
