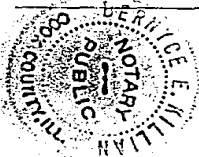

And the said grantor hereby expressly waives, surrenders and releases, in any and all right or benefit under and by virtue of any and all statutes of the State of Illinois, providing for the exemption of homesteads from sale on execution of judgments or otherwise.
