Lot 41 and the North 5 feet of Lot 40 in Block 96 in Cornell in Section 26, Township 38 North, Range 14, East of the Third Principal Meridian, in Cook County, Illinois

TO HAVE and to hold the same, with all appurtenances thereto belonging, to the said MARIE CAMPBELL, formerly known as MARIE MCKINNEY, her heirs and assigns forever.

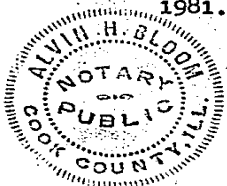
