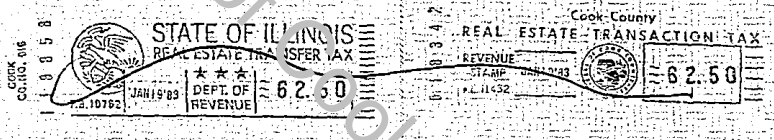

General real estate taxes for the year 1982 and following years and to covenants, easements and restrictions of record, if any.

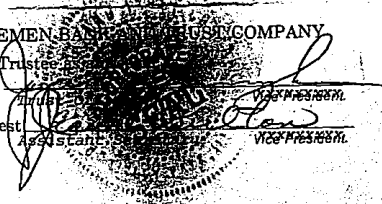
