WARRANTY DEED

The Grantor, PULTE HOME CORPORATION, a corporation created and existing under and by virtue of the laws of the State of Delaware, for and in consideration of the sum of Ten Dollars (\$10.00) and other good and valuable consideration in hand paid, does hereby CONVEY AND WARRANT unto Grantee, David R. Brothman and Judy K. Brothman, his wife as joint tenants with the right of survivorship and not as tenants in common, the following described real estate situated in Cook County, Illinois; to wit:

PARCEL I:

Lot 67 in New Salem Unit 2, being a Subdivision of part of the Southwest 1/4 of Section 29 and part of the Southeast 1/4 of Section 30, all in Township 41 North, Range 10, East of the Third Principal Meridian, according to the Plat of Subdivision recorded November 1, 1982 as Document 26,397,454, in Cook County, Illinois.

PARCEL II:

Easement for ingress and egress over Out Lots 1 in New Salem Units 1 and 2 appurtenant to Parcel I as set forth in the Hartford Square Declaration of Covenants, Conditions and Restrictions recorded November 19, 1982 as Document 26,417,658

TO HAVE AND TO HOLD unto said Grantee forever as joint tenants with the right of survivorship and not as tenants in common, subject to:

- (a) General taxes not yet due and payable;
- (b) Easements of Record;
- (c) Roads and rights of way;
- (d) Covenants, conditions and restrictions of record, including those appearing in Hartford Square Declaration of Covenants, Conditions and Restrictions and any Amendments thereto;
- (e) Building lines of record;
- (f) Building and zoning laws and regulations; and
- (g) Rights-of-way for drainage ditches, tiles, feeders and laterals.
