Grantor also conveys an easement for ingress and egress over the West 10 ft. of the South 55 ft. of lot 1 in Cachey's 159th Street Resubdivision of lot 27 in Veritas etc. and reserves to himself, successors and assigns, an easement for ingress and egress over the East 20 ft. of the South 55 ft. of lot 2 in Cachey's 159th Street Resubdivision of lot 27 in Veritas etc.

Subject to: General Real Estate Taxes for the year 1982 and subsequent years; easements, conditions and restrictions of record.

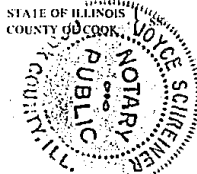
