

TRUSTEE'S INDENTURE OF SUCCESSION IN TRUST

THIS INDENTURE made this 25TH day of JANUARY, 19 83, between THE EXCHANGE NATIONAL BANK OF CHICAGO, a national banking association, not personally, but as trustee under the provisions of deeds in trust, duly recorded and delivered to said bank in pursuance of trust agreements, said bank being trustee under the various trusts as listed on the attached rider which is an integral part of this deed, party of the first part, and

LASALLE NATIONAL BANK, a national banking association, as successor trustee under the aforesaid various trusts listed on the attached rider, party of the second part.

WITNESSETH, that said party of the first part, in consideration of the sum of TEN DOLLARS, and other good and valuable considerations in hand paid, does hereby convey and quitclaim unto said party of the second part,

all of the land held in the aforesaid trusts, in COOK COUNTY ILLINOIS

together with the tenements and appurtenances thereunto belonging.

TO HAVE AND TO HOLD the same unto said party of the second part, and to the proper use, benefit and behoof forever of said party of the second part on the same trust terms as same had been held by the party of the first part with all of the powers and duties given in said various trusts.

This indenture is executed pursuant to and in the exercise of the power and authority granted to and vested in said party of the first part as trustee by the terms of said deeds in trust delivered to said party of the first part as trustee in pursuance of the trust agreements above mentioned. This indenture is made subject to the lien of every trust deed or mortgage (if any there be) of record given to secure the payment of money, and remaining unreleased at the date of the delivery hereof, and subject to all covenants and restrictions and conditions of record.

IN WITNESS WHEREOF, said party of the first part has caused its corporate seal to be hereto affixed, and has caused its name to be signed to these presents by its Assistant Vice President and attested by its Trust Officer the day and year first above written.
