Hamblin and Lynn M. Hamblin, his wife as joint tenants with the right of survivorship and not as tenants in common, the following described real estate situated in Cook County, Illinois; to wit:

PARCEL I

Lot 31 in New Salem Unit 2, being a Subdivision of part of the Southwest 1/4 of Section 29 and part of the Southeast 1/4 of Section 30, all in Township 41 North, Range 10, East of the Third Principal Meridian, according to the Plat of Subdivision recorded November 1, 1982 as Document 26,397,454, in Cook County, Illinois.

Easement for ingress and egress over Out Lots 1 in New Salem Units 1 and 2 appurtenant to Parcel I as set forth in the Hartford Square Declaration of Covenants, Conditions and Restrictions recorded November 19, 1982 as Document 26,417,658

TO HAVE AND TO HOLD unto said Grantee forever, as joint tenants with the right of survivorship and not as tenants in common, subject to:

- (a) General taxes not yet due and payable;
- (b) Easements of Record;
- (c) Roads and rights of way;
- (d) Covenants, conditions and restrictions of record, including those appearing in Hartford Square Declaration of Covenants, Conditions and Restrictions and any Amendments thereto;
- (e) Building lines of record;
- (f) Building and zoning laws and regulations; and
- (g) Rights-of-way for drainage ditches, tiles, feeders and laterals.

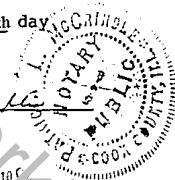
