TOGETHER with all provements, tenements, easements, fixtures and appurtenances thereto belonging, and all rents, issues and profits therec 'for of ig and during all such times as Granton(s) may be entitled thereto (which are pledged primarily and on a parity with said real ruate and not secondarily) and all apparatus, equipment or articles now or hereafter therein or thereon used to supply heat, gas, air conditioning, water, light, power, refrigeration (whether single units or centrally controlled), and ventilation, including (without res ricting the foregoing), screens, window shades, storm doors and windows, floor coverings, or not, and it is agreed that all similar apr tratty, equipment or articles hereafter placed in the premises by the Grantor(s) or their successors or assigns shall be considered as constituting part of the real estate.

GRANTOR(S) AGREE to pay all taxes of dissessments upon said property when due, to keep the buildings thereon insured to their full insurable value, to pay all prior e.c. noraces and the interest thereon and to keep the property tenantable and in good repair and free of liens. In the event of failure ( Grant ), to comply with any of the above covenants, then Trustee is authorized at its option to attend to the same and pay the bills therefor, which shall with 9% interest thereon, become due immediately, without demand. On default in any payments tue in accordance with the note secured hereby or any renewals or extensions thereof, or in the event of a breach of any covenant here a co. tained, Trustee may declare the whole indebtedness due together with interest thereon from the time of such default or breach, as are ay proceed to recover such indebtedness by foreclosure thereof, or by suit at law, or both, as if all of said indebtedness had t' en maured by express terms.

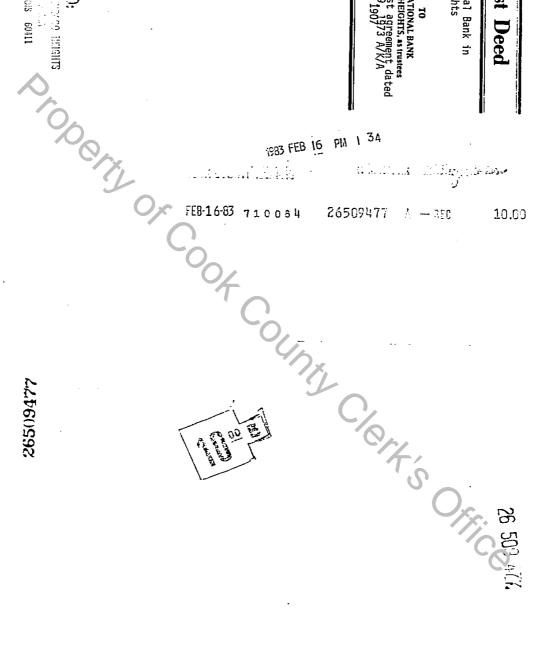
