THE COVENANTS, CONDITIONS AND PROVISIONS REFERRED 10 ON PAGE 1 (THE REVERSE SIDE OF THIS TRUST DEED):

1. Mottages shall (1) promptly repair, restore or rebuild any buildings or improvements now or hereafter on the premises which may become damaged be destroyed; (2) keep said premises in good condition and repair, without waste, and free from mechanic's or other liens or claims for lien not expressly bordinated to the lien hereof; (3) pay when due any indebtendents which may be secured by a lien or charge on the premises superior to the lien hereof; and using the process of the control of the discharge of such prior lien to Trusted by a lien or charge on the premises superior to the lien hereof, and using no buildings now or at any time in process of exception upon said greenises; (5) comply with all requirements of law or municipal ordinances with appect to the premises and the use thereof; (6) make no process of remains in said premises except as required by law or municipal ordinances.
