THE COVENANTS, CONDITIONS AND PROVISIONS REFERRED TO ON PAGE 1 (THE REVERSE SIDE OF THIS TRUST DEED):

1. Mertgagers shall (a) promptly repair, rentor or rebuild any buildings or improvements now or hereafter on the premises which may become damaged or be destroyed; (b) keep said premises in good conditions and repair, without waste, and free from mechanic's or other lies or claims for lies not expressly subsolutinated to the lies hereof; (c) gay when due any inhebtedness which may be secured by a lien or charge on the premise; aspecior to the lien hereof, and upon request exhibit suifactory evidence of the discharge of such prior lien to Trustee or to premise; (s) comply with all requirements of law or municipal ordinance.

Trustee has no duty to examine the title, location, existence or condition of the premises, or so inquire into the validity of the signatures or the identity, capacity, or authority of the signatories on the note or trust deed, nor shall Truste be of cleated to record this trust deed or to exercise any power herein given unless expressly obligated by the terms hereof, nor be liable for an 'a 't or omissions hereunder, except in case of its own gross negligence or misconduct or that of the agents or employees of Trustee, and 't may require indemnities satisfactory to it before exercising any power herein given.

13. Trustee shall release this trust deed and the lien thereof by proper instrument upon presentation of satisfactory educe that all indebtedness secured by this trust deed has been fully paid; and Trustee may execute and deliver a release hereof to an lat the request of any person who shall, either before or after maturity thereof, produce and exhibit to Trustee the note, representing that all 'the sheets such successor trustee may accept as the genuine note herein described any note which bears an identification number purpority to be executed by the persons herein designated as the makers thereof; and where the release is requested of the note and which previous herein designated as the makers thereof; and where the release is requested of the original trustee and has never placed its identification number on the note described herein in way accept as the genu

14. Trustee may resign by instrument in writing filed in the office of the Recorder or Registrar of Titles in which this instrument shall have been recorded or filed. In case of the resignation, inability or refusal to act of Trustee, the then Recorder of Deeds of the county in which the premises are situated shall be Successor in Trust. Any Successor in Trust hereunder shall have the idential title, powers and authority as are herein given Trustee.

This Trust Deed and all provisions hereof, shall extend to and be binding upon Mortgagors and all persons claiming under or through Mortgagors, and the word "Mortgagors" when used herein shall include all such persons and all persons liable for the payment of the indebtedness or any part thereof, whether or not such persons shall lave executed the note or this Trust Deed. The word "note" when used in this instrument shall be construed to mean "notes" when more than one note is used.

16. Before releasing this trust deed, Trustee or successor shall receive for its services a fee as determined by its rate schedule in effect when the release deed is issued. Trustee or successor shall be entitled to reasonable compensation for any other act or service performed under any provisions of this trust deed. The provisions of the "Trust And Trustees Act" of the State of Illinois shall be applicable to this trust deed.
