Part of certain Lots and part of vacated Wellington Lane all in Orland Square Village Unit One, being a subdivision of part of the West Half of the Northeast Quarter and the East Half of the Northwest Quarter and the East Half of the Southwest Quarter of Section 15, Township 36 North, Range 12 East of the Third Principal Meridian, in Cook County, Illinois; also part of the East Half of the Southwest Quarter of Section 15 aforesaid.
