### EXHIBIT A

#### Parcel 1:

That part of Block 1 in Canal Trustees' Subdivision of Fractional Section 3, Township 39 North, Range 14 East of the Third Principal Meridian, described as follows: Beginning at the Southwest Corner of said Block at Northeast Corner of Elm Street and State Street; and running thence East 95 feet more or less to an alley 10 feet wide; thence North 95.08 feet along the West line of said alley; thence West to the West line of said Block, being the East line of said State Street, as located; thence South 95.08 feet to the point of beginning.

#### Parcel 2

That part of the South half of Block 1 in the Canal Trustees' Subdivision of the South Fractional half of Section 3, Township 39 North, Range 14 East of the Third Principal Meridian and described as follows: Beginning at a point on the Wert line of said Block 1, 95.08 feet North from the Southwest Corner thereof and running thence East on a line parallel with the South line of said Block 1 said South line being the North line of East Elm Street; 95 feet more or less to an alley 10 feet wide; thence North 24.25 feet; thence Vert 95 feet more or less to the West line of Block 1; thence South 24.25 feet to the point of beginning in Cook County, Firinois.

## Parcel 3:

A strip of land 5.0 feet wide, lying W.s. of and adjoining the East line of the West 132.50 feet cf the South half of Block l in Canal Trustees' Subdivision of South Fractional half of Section 3, Township 39 North, Range 14 East of the Third Principal Meridian, excepting therefrom that part thereof dedicated for Public Alley by Document No. 357645 Recorded November 7th, 1881, said strip of land being the West half of the 10 foot Private Alley created by lead Recorded January 3rd, 1859, and Rerecorded March 5to. 1884, as Document No. 529001, in Cook County, Illinois.
