JUDGE'S DEED

South ten (10) feet of Lot 25 and Lot 26 (except the South five (5) feet) in Block One in the 79th Street Additional to Cheltenham Beach and the Northwest 1/4 of Section 31, Township 38 North, Range 15 East of the Third Principal Meridian, in Cook County, Illinois.

to have and to hold the same with all the appurtenances thereto belonging to the said DOROTHY GREEN, her heirs and assigns forever, who resides at 7951 South Kingston Avenue, Chicago, Illinois.

THIS DEED is executed and delivered solely in compliance with the Judgment of the Court hereinabove referred to.

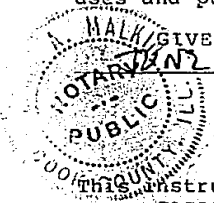
