1. Mortgagers shall (a) promptly repair, restore or rebuild any buildings or improvements now or hereafter on the premises which may become damaged or be destroyed; (b) keeps sid premises in good conditions and regain, without water, and fire from mentals or other lens of the continuous properties of the control of the co
