JUDGE'S DEED

WHEREAS, on the 14th day of March, 1983, in Case No. 81 D 25215, entitled "In re the Marriage of JOHN M. COLOMBO and BARBARA M. COLOMBO", Counter Petitioner, BARBARA M. COLOMBO, was granted a Judgment for Dissolution of Marriage; which said Judgment provided that JOHN M. COLOMBO should within (10) ten days from the date of said Judgment execute and deliver to BARBARA M. COLOMBO a Deed conveying all of the interest in the real estate hereinbelow described;

COLOMBO of 2903 Briarwood Arlington Heights, Illinois, her heirs and assigns forever, the following described premises, to-wit:

Lot 22 (except the North 87 feet thereof) and Lot 21 (except Southwesterly 68 feet thereof as measured at right angles to Southwesterly line of said Lot 21) in Lake Briarwood, a subdivision of part of the West 1/2 of the East 1/2 of Section 22, Township 41 North, Range 11 East of the Third Principal Meridian, in Cook County, Illinois.

To have and to hold the same, with all appurtenances thereto belonging, to the said BARBARA M. COLOMBO, her heirs and assigns forever.

This Deed is executed and delivered solely in compliance with the Judgment hereinabove referred to.

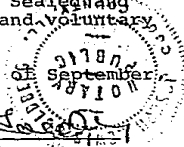
