agreement dated the 31st day of December A. D. 1980, and known as Trust No. 51322T, party of the first part, and NORMAN K. SOLOMON, JR., a

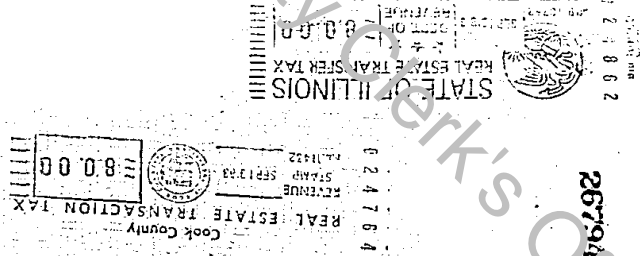
Bachelor, of the Village of Skokie, County of Cook and State of Illinois, party of the second part,

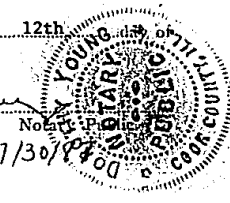

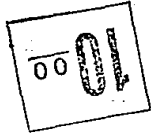
