1. Mortgagers shall, (a) promptly repair, restore or rebuild any buildings or improvements now or herafeter on the premises which may become damaged or be destroyed; (b) keep said premises in good condition and repair, without waste, and free from mechanic's or other them or charme for him not expressly subordinated to the lien hereof; (c) pay when due any inguistedness which may be secured by a lien or charge on the premises superior to the lien hereof, and upon request exhibit sailsfactory evident of the discharge of such piles to Trustee or to holders of the note; (d) complete within a reasonable time any building or buildings now of at any time in process of exection upon said repairs.
