in the State of Illinois, to wit:

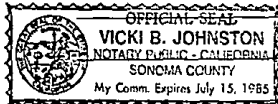

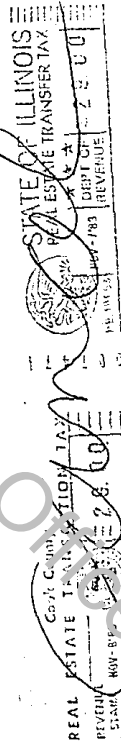
