JUDGE'S DEED

TO HAVE and to hold the same, with all appurtenances there-to belonging, to the said Mary Adams, her heirs and assigns forever.

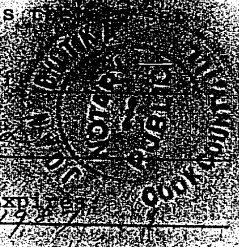

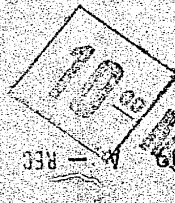
