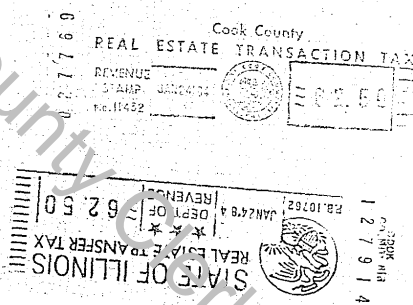
Trustee's Deed Joint Tenancy

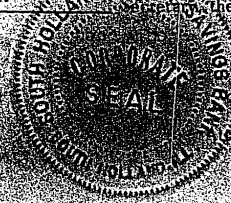
together with the tenements and appurtenances thereunto belonging.

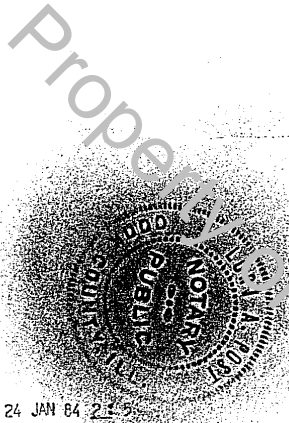
