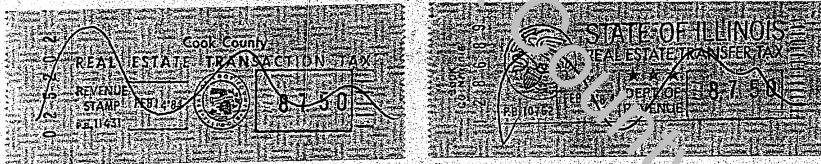

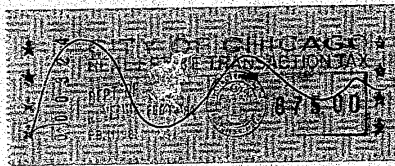

A tract of land being part of Block 11 in W. F. Kaiser and Company's Ardair Subdivision of the West half of the South West quarter and the West three-quarters of the East half of the South West quarter (except Railroad right of way) of Section 10, Township 38 North, Range 13, East of the Third Principal Meridian, said tract of land being described as follows: Beginning at the North East corner of said Block 11, said North East corner being the intersection of the South line of Archer Avenue with the West line of the Chicago and Western Indiana Railroad right of way and running thence South Westerly along the North line of said Block 11 to its intersection with the East side of Knox Avenue; thence Southerly along the East side of Knox Avenue 365 feet to a point; thence Easterly on a line perpendicular to the East side of said Knox Avenue, 247.77 feet to the Westerly line of the Chicago and Western Indiana Railroad, being the Easterly line of land deeded by Consumers Company to Arthur E. Nelson and Emma Nelson as Trustees under the will of Nels Nelson deceased dated September 29, 1950 and recorded in Records Office in Cook County, Illinois on October 6, 1950 as Document No. 14920810; thence North Easterly along the Westerly line of said Chicago and Western Indiana Railroad to a point in the East line of said Block 11 which is 165.15 feet South of the North East corner of said Block 11; thence North 165.15 feet along the East line of said Block 11 to the place of beginning, in Cook County, Illinois.
