THIS INDENTURE, made this 6th day of March, 1922, between AMERICAN NATIONAL BANK AND TRUST COMPANY OF CHICAGO, a corporation duly organized and existing as a national banking association under the laws of the United States of America, and duly authorized to accept and execute trusts within the State of Illinois, not personally but as Trustee under the provisions of a deed or deeds in trust duly recorded and delivered to said national banking association in pursuance of a certain Trust Agreement, dated the 31st day of March, 1922, and known as Trust Number 15643, of the first part, and Robert E. Brandt & Lorraine H. Brandt, his wife, 834 Community Drive, La Grange Park, Illinois, parties of the second part.

WITNESSETH, that said party of the first part, in consideration of the sum of Ten and no/100 \$10.00 Dollars, of other good and valuable considerations in hand paid, does hereby grant, sell and convey unto said parties of the second part, not in tenancy in common but in joint tenancy, the following described real estate, situated in Cook County, Illinois, to-wit:

Lot 22 in Block One in Westmoorland, a Subdivision of the South West quarter of the North East Quarter of Section Thirty-Three Township Thirty-Nine North, Range Twelve, East of the Third Principal Meridian, and all of that part of the South East Quarter of the North West Quarter of said Section Thirty-Three, lying East of Fifth Avenue in Cook County, Illinois.



together with the tenements and appurtenances thereto belonging. TO HAVE AND TO HOLD the same unto said parties of the second part, forever, not in tenancy in common, but in joint tenancy.

This deed is executed by the party of the first part, as Trustee, as aforesaid, pursuant to and in the exercise of the power and authority granted to and vested in it by the terms of said Deed in Trust and the provisions of said Trust Agreement, aforesaid, and of every other power and authority thereunto extending. This deed is made subject to the liens of all trust or mortgage mortgages, liens and real estate, if any, recorded or registered in said county.
