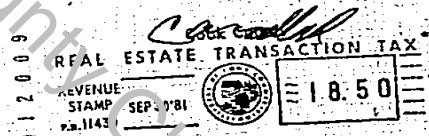
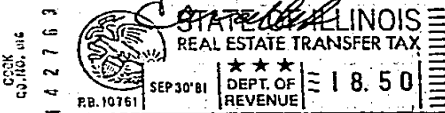
This Indenture, made this 14th day of August, 1981
