Mortgagor shall (1) promptly repeir, restore or rebuild any buildings or improvements now or hereafter on the premises which may become damor be destroyed; (2) keep said premises in good condition and repair, without waste, and free from mechanic's or other litens or claims for lien not sessly subsordinated to the lien hereof; (3) pay when due any indebtedness which may be secured by a lien or charge on the premises superior to the hereof, and upon request exhibit satisfactory evidence of the discharge of such prior lien to Trustee or to holders of the note; (4) coinplete within a mable time any building or buildings now or at any time in process of erection upon said premises; (5) comply with all requirements of law or icipal ordinances with respect to the premises and the use thereof; (6) make no material alterations in said premises except as required by law or icipal ordinance.

- In the event of any conflict between the terms hereof and the terms of the Mortgage, the terms hereof shall control;
- 2. Francis H. Lanz, at the present time is the holder of the Note secured hereby (the term "Holder" shall include Francis H. Lanz, his successors and assigns);
- 3. As additional security hereunder, Mortgagor hereby assigns to the Holder the rents of the premises, provided that Mortgagor shall, prior to acceleration of the debt secured hereby by reason of default or abandonment of the premises, have the right to collect and retain such reas as they become due and payable.

Upon acceleration by reason of default or abandonment of the premises, and at any time prior to the expiration of any period of redemption following judicial sale, the Holder, in person, by agent or by judicially appointed receiver, shall be entitled to enter upon, take possession of and manage the premises and to collect the rents of the premises including those past due. All rents collected by Holder or the receiver shall be applied first to payment of the costs of management of the premises and collection of rents, including, but not limited to receiver's fees, premiums on receiver's bonds and reasonable attorney's fees, and then to the sums secured by this Mortgage. Lender and the receiver shall be liable to account only for those rents actually received.

4. Mortgagor shall not, without the advance written consent of the Holder, sell or transfer all or any portion of the premises or any interest therein, lease any portion of the premises for a period (including any option period) in excess of 3 years or transfer direct or indirect control of Northwestern Plating Works Inc. to any person or entity not presently a shareholder thereof. The above limitation shall not apply to (a) the creation of a lien or encumbrance subordinate to this Mortgage, (b) the creation of a purchase money security interest for fixtures, (c) a transfer by
