That part of the Southeast 1/4 of the Northwest 1/4 of section 8, Township 35 North, Range 14, East of the Third Principal Meridian, lying east of the easterly right of way line of the public roadway formerly known as Riegle Road and North of the North right of way line of Frances Lane heretofore dedicated and recorded December 27, 1963 as Document No. 18980780, excepting therefrom the North 33 feet thereof (South of Holbrook Road) all in Cook County, Illinois.
