the following described Real Estate situated in the County of Cook and State of Illinois, to wit:

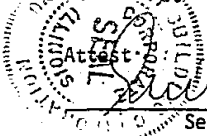
Unit No. 1-C, Building CT-1, in the Norwood Courts Condominium, as delineated a survey of the following described real estate:
