  2. Morgagors shall (1) promptly repair, restore or rebuild any building or improvements now or hereafter on the premises which may become danaged or be destroyed;
  (2) net per said premises in good condition and repair, without waste, and free from mechanic's or other lines or claims for line not expressly subordinated to the lien hereof;
  (3) pay when due any indebtenderss which may be secured by a lien or charge on the premises superior to the lien hereof, and proprietous exhibit statisfactory evidence of the discharge of such prior lien to Trustee or to holders of the nore; (4) complete within a reasonable time; any buildings now or at any time in process of exection upon said premises; (5) comply with all requirements of law or municipal ardinances with respect (or the premises and the use thereof; (6) make no material alreations in said premises except as required by law or municipal ardinance.

- 16. Without the prior written consent of the holder or holders of the note secured hereby, the Morigagor or Mo or pore shall not convey or encomber title to the premises herein involved. The holder or holders of the note secured hereby may effect to accelerate the entire unput principal balance as provided in the note for breach of this covenant and no delay to such election after actual or constructive notice, d. such the second hiddle to construct as a waiver of or accule scence in any such above sacce or encumbrance.

  17. This Trust Deed shall secure. any tuture advances made by the Morigagor, for any purpose, at any time before the release and cancellation of this morigage, but at no time shall this morigage secure advances on account of said original note and such additional advanc, us a unit neckess of Nine. Thousand, and. No/1001s.

  Dollars (9 000 00 ), provided that nothing herein contained shall be considered as limiting the amounts that shall be sure in y when advanced to protect the security or in accordance with covenants contained in the mortgage."
