THE FOLLOWING ARE THE COVENANTS, CONDITIONS AND PROVISIONS REFERRED TO ON PAGE 1 (THE REVERSE SIDE OF THIS TRUST DEED) AND WHICH FORM A PART OF THE TRUST DEED WHICH THERE BEGINS:

- 1. Mortgagors shall (1) keep said premises in good condition and repair, without waste: (2) promptly repair, restore, or rebuild any buildings or improvements now or hereafter on the premises which may become damaged or be destroyed; (3) keep said premises free from mechanics liens or liens in favor of the United States or other liens or claims for lien not expressly subordinated to the lien hereof; (4) pay when due any indebtedness which may be secured by a lien or charge on the premises superior to the lien hereof, and upon request exhibit satisfactory evidence of the discharge of such prior lien to Trustee or to holders of the note; (5) complete within a reasonable time any buildings now or at any time in process of crection upon said premises; (6) comply with all requirements of law or municipal ordinances with respect to the premises and the use thereof; (7) make no material alterations in said premises except as required by law or municipal ordinance or as previously consented to in writing by the Trustee or holders of the note.
- 2. Mortgagors shall pay before any penalty attaches all general taxes, and shall pay special taxes, special assessments, water charges, sewer service charges, and other charges against the premises when due, and shall, upon written request, furnish to Trustee or to holders of the note the original or duplicate receipts therefor. To prevent default hereunder Mortgagors shall pay in full under protest, in the manner provided by statute, any tax or assessment which Mortgagors may desire to contest.
- 3. Mortgagors shall keep all buildings and improvements now or hereafter situated on said premises insured against loss or damage by fire, lightning and wi dstorm under policies providing for payment by the insurance companies of moneys sufficient either to pay the cost of replacing or repairing the sain or to pay in full the indehedness secured hereby, all in companies satisfactory to the holders of the note, under insurance policies pays in rase of loss or damage, to Trustee for the benefit of the holders of the note, such rights to be evidenced by the standard mortgage clause obs. attached to each policy, and shall deliver all policies, including additional and renewal policies, to holders of the note, and in case of insurance about to expire, shall deliver renewal policies not less than ten days prior to the respective dates of expiration.

Trustee or the holders of the note may, but need not, make any payment or perform any act hereinbefore required of Mortgagos, in any form and manner deemed expedient, and may, but need not, make full or partial payments of principal or interest on prior encumbrances. If a und purchase, discharge, compromise or settle any tax lien or other prior lien or title or claim thereof, or redeem from any tax sale or fort that affecting said premises or contest any tax or assessment. All moneys paid for any of the purposes herein authorized and all expenses paid one red in connection therewith, including reasonable attorneys' fees, and any other moneys advanced by Trustee or the holders of the note to proceed an mortgaged premises and the lien hereof, plus reasonable compensation to Trustee for each matter concerning which action herein authorized any y be taken, shall be so much additional indebtedness secured hereby and shall become immediately due and payable without notice and with any "ext thereon at the rate of eight per cent per annum, Inaction of Trustee or holders of the note shall never be considered as a waiver of any "ght' ceruing to them on account of any default hereunder on the part of Mortgagors.

Such appointment may be made either before or after sale, without notice, thout regard to the solvency or insolvency of Mortgagors at the time of application for such receiver and without regard to the then value of an epremises or whether the same shall be then occupied as a homestead or not and the Trustee hereunder may be appointed as such receiver, such receiver, such profits of said premises during the pendency of such foreclosure suit and, in case of a sale and a efficiency, during the full statutory period for redemption, whether there be redemption or not, as well as during any further times when i lortgagors, except for the intervention of such receiver, would be entitled to collect such rents, issues and profits, and all other powers which may a poec sary or are usual in such cases for the protection, possession, control, management and operation of the premises during the whole of said perio. been recorded or filed. In case of the death, resignation, inability or refusal to act of Trustee,

in which the premises are situated shall be second Successor in Trust. Any Successor in Trust hereunder shall have the identical title, powers and
authority as are herein given Trustee, and any Trustee or successor shall be entitled to reasonable compensation for all acts performed hereunder.
