THIS INDENTURE WITNESSETH, That the Grantor Barbara Rock Sabel, a married woman, (previously known as Barbara Rock Olson) & Edward R. TO HAVE AND TO HOLD the said premises with the appurtenances upon the trusts and for the uses and purposes herein and in said trust agreement set forth.

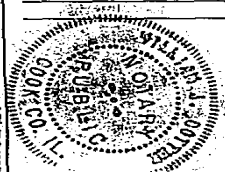
