PIERCE, JR., Secretary of Housing and Urban Development, of Washington, D.C., acting by and through the Federal Housing Commissioner, (hereinafter referred to as "Grantor"), for and in consideration of the sum of ONE DOLLAR (\$1.00) in hand paid, and other good and valuable consideration conveys to Charles Jones and Gloria Jones as Joint Tenants and not as Tenants in Common, 1032 Charlesworth, Joliet, IL 60432 (hereinafter referred to as "Grantee(s)"), all interest in the following described real estate.

Lot 15 and 16, in Block 4, in Sylvan Hills, a Subdivision of the West part of Lot 2 of Woodruff and Nichols' Second Subdivision of part of the Southwest quarter of Section 2 in Township 35 North and in Range 10 East of the Third Principal Meridian, lying North of the Elgin, Joliet and Eastern Railroad Company right of way in Will County, Illinois, commonly known as 807 Ewing, Joliet, IL

SAID CONVEYANCE is made SUBJECT to all covenants, restrictions, easements, reservations, conditions and rights appearing of record against the above described property; also SUBJECT to any state of facts which an accurate survey of said property would show.

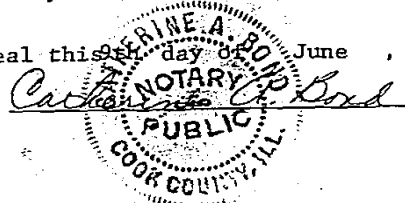
