The South 64 Feet, 4 1/2 inches of Lots 11 and 12 in Block 9 in McIntosh and Company's addition to Des-Plaines Heights, being a subdivision of that part East of Railroad of the South Half of the Southeast Quarter of Section 20, Township 41 North, R 12, East of the 3rd Principal Meridian, and that part West of Des Plaines Road of the South Half of the Southwest Quarter (except 4 Acres in the Northeast Corner Thereof) of Section 21, Township 41 North, R 12, East of the Third Principal Meridian, in Cook County, Illinois.

TO HAVE and to hold the same, with all appurtenances there-to belonging, to the said JUNE BERNICE DANZ, her heirs and assigns forever.

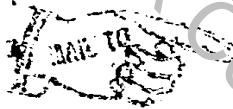
