PIERCE, JR., Secretary of Housing and Urban Development, of Washington, D.C., acting by and through the Federal Housing Commissioner, (hereinafter referred to as "Grantor"), for and in consideration of the sum of ONE DOLLAR (\$1.00) in hand paid, and other good and valuable consideration conveys to PALCOS BANK AND TRUST AS TRUSTEE UNDER TRUST NUMBER 1-1834 DTD 11-16-81 (hereinafter referred to as "Grantee(s)"), all interest in the following described real estate.

The North one half (1/2) of Lot Thirty Five (35) and all of Lot Thirty Six (36) in Block Two (2) in A.W.
