THIS INDENTURE WITNESSETH: That SAMUEL R. PIERCE, Secretary of Housing and Urban Development, of Washington, D.C., acting by and through the Federal Housing Commissioner, (hereinafter referred to as "Grantor"), for and in consideration of the sum of ONE DOLLAR (\$1.00) in hand paid, and other good and valuable consideration conveys to AMERICAN NATIONAL BANK AS TRUSTEE UNDER TRUST NUMBER 53958, under Trust Agreement dated April 19, 1982 (hereinafter referred to as "Grantee(s)"), all interest in the following described real estate.

Lot 21 (except the East 18.75 feet thereof) and all of Lot 22 in Block 4 in Sweet Cole and Buell's Subdivision of Lot 1 and Lot 2 of Hunter's Subdivision of the N.W. 1/4 of Section 31, Township 33 North, Range 14, E. of the Third Principal Meridian, in Cook County, IL, commonly known as 2053 W. 79th Pl., Chicago, IL.
