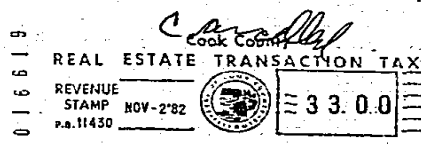
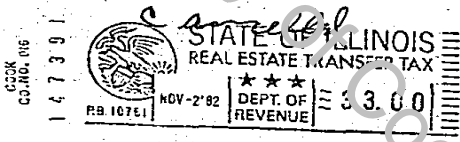
TRUSTEE'S DEED

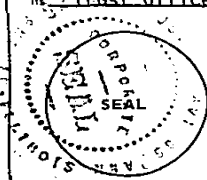
