LEGAL DESCRIPTION RIDER

That part of the West Half of Government Lot 1 of the North East Quarter of Section 2 and that part of the South East Quarter of the North West Quarter of Section 2, Township 42 North, Range 12 East of the Third Principal Meridian, described as follows: Beginning at a point in the Northeasterly line of Dennis Subdivision (which subdivision is described in plat recorded as document No. 14609563 in Book of Plats No. 378, Page 38, recorded on August 11, 1949) 25 feet North Westerly of the most Easterly corner of said Lot 11 of said Subdivision running thence South Westerly on a line parallel with the South Easterly line of said Lot 11 and the same extended South Westerly to the North Easterly line of the right of way of Public Service Company of Northern Illinois; thence North Westerly along the last mentioned line to its point of intersection with the North Westerly line of Lot 7 of said subdivision produced to the North Easterly line of the right of way of the Public Service Company of Northern Illinois; thence running North Easterly along the said produced line of said Lot 7 to the most Northerly corner of said Lot 7; thence running South Easterly along the Northeasterly line of said Dennis Subdivision to the place of beginning, all in Cook County, Illinois.
