common elements.



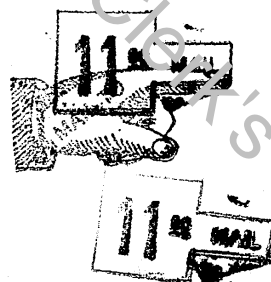
