If the foregoing covenant and condition shall be violated, this Deed of Gift shall become forfeited and the parcels herein described and all the rights herein conveyed shall at once revert to and revest in and become the property of Grantor, its successors and assigns, without any declaration of forfeiture or act of re-entry, and without any other act by Grantor to be performed, and without any right of Grantee to reclamation or compensation for moneys paid or improvements made, as absolutely, fully and perfectly as if this Deed of Gift had never been made.
