This Indenture, Made this 28th day of February A. D. 19 85,

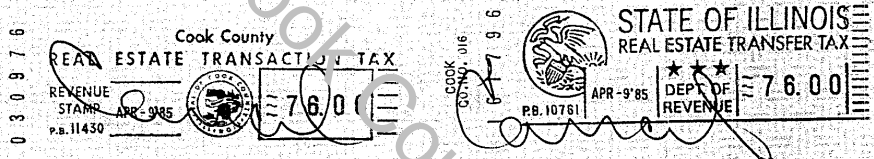
