This Indenture,

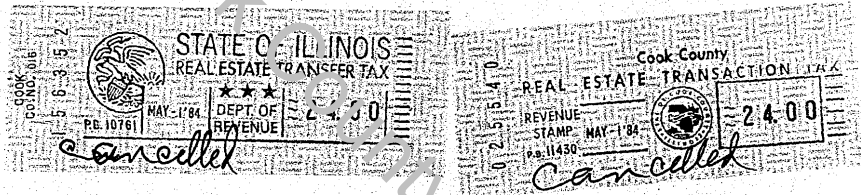
Made this 27th day of April, 1984,
